

This is what's happening. With \$4 TRILLION in new spending by Biden, the national debt is now \$32 TRILLION – which is \$620,000 owed by every American. The biggest pot of money Joe Biden and Democrats are looking to grab for their Big Government socialist spending schemes is Social Security (FICA) tax revenue.

We at <b>60 Plus</b> are mobilizing millions of American seniors to pressure Congress to pass the " <b>Social Security Guarantee Act</b> " – which, if enacted, would accomplish these four crucial things to protect your Social Security:
1) Prohibits Congress from eliminating your Social Security income. Under current law, you have no legal protection for your Social Security income. Tax money collected to fund Social Security (FICA) is just combined with GENERAL tax revenue and can be spent (squandered) by Congress on anything they please.
2) Guarantees the right of American seniors to receive Social Security benefits "in full with an accurate annual cost-of-living adjustment."
<b>3) Guarantees</b> that you will continue to receive Social Security by treating your Social Security benefits as your legal property – in the same way that your home is property.
<b>4) You would receive a Certificate</b> from the U.S. Treasury Department certifying that your Social Security benefits belong to you, not the U.S. government, and can never be taken away – similar to a U.S. Treasury bond.
